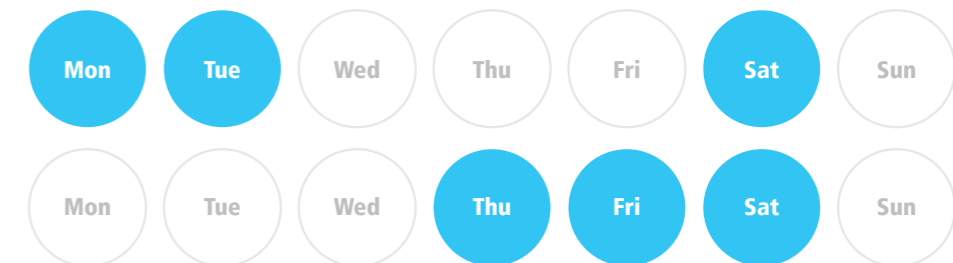

## Financing your studies

All applicants may apply for a scholarship in the online application. Scholarships cover a partial amount of the tuition fee for the respective programme.

### FS Scholarship

The FS scholarship is merit-based and considers extracurricular activities, social commitment, intercultural skills, international experience, professional experience and academic performance.

### KPM Scholarship

A total of one million euro has been donated by Prof. Dr. h.c. Klaus-Peter Müller (KPM) in order to support German students with outstanding profiles on a needs and merit basis.

### FIRM Scholarship

Frankfurt Institute for Risk Management and Regulation supports the Master of Finance students who take the Risk Management concentration. Members of this concentration will have the opportunity to win the monetary Risk Management award, which is presented during the graduation ceremony.

### Scholarship for Armenian Students

From now on talented Armenian students have a great opportunity to focus on their education without worrying about tuition fees. Frankfurt School in collaboration with Vahe and Bella Andonians offer a limited number of merit-based full tuition fee waivers for Armenian students.

## Lifelong Learning

Starting the weekend after the graduation ceremony, Frankfurt School will be offering four weekend workshops, one per semester over the following two years so students can benefit from continually developing their knowledge and experiences. Following the admission decision, the Scholarship Committee will review scholarship applications. To be considered for a scholarship you must complete the relevant section within the online application.

### Programme structure

The first semester will be structured over a 5 day week, allowing students to attend lectures and be supported with **applied tutorial sessions**. This structure will support a comprehensive experience for students to gain core competencies crucial for the success of the programme and in their careers. In the second semester, students will transition to the traditional 3-day model our master students enjoy. The 3-day model supports students by allowing them to study 3 days a week, gain practical experience alongside their studies and have time to be involved in on campus extra-curricular activities. The fourth semester will allow students to study **entrepreneurship**, gain international experience **studying abroad** or participate in the **electives** offered at FS.

### Hands-on experience

Coming from non-traditional backgrounds, gaining **practical experience** during your studies is invaluable to your future success upon graduation. 6 ECTS will be given for working student positions or internships taken during any time of your programme, alongside your studies or during summer break.

### International perspectives

Students of the Master in Financial Management will travel as a group to a European city to experience the world of Finance outside of Frankfurt. In past years, Frankfurt School students have travelled to Luxembourg, Brussels and Lisbon. We look forward to continuing on this tradition with a new group of students! The purpose is to **expose students to the EU’s socio-economic and political affairs** and expand their knowledge about sustainable finance, climate change and the UN’s Sustainable Development Goals (SDGs).

### Develop your skills

The Master in Financial Management will incorporate the teaching styles of accomplished academics as well as successful professionals working in your future fields. Along with traditional lectures, students will study in an **international environment** focusing on developing **strong academic competencies**, and with the use of case studies, group work and presentations, students will **expand their practical know-how** and **develop their soft skills**, crucial to any career path.

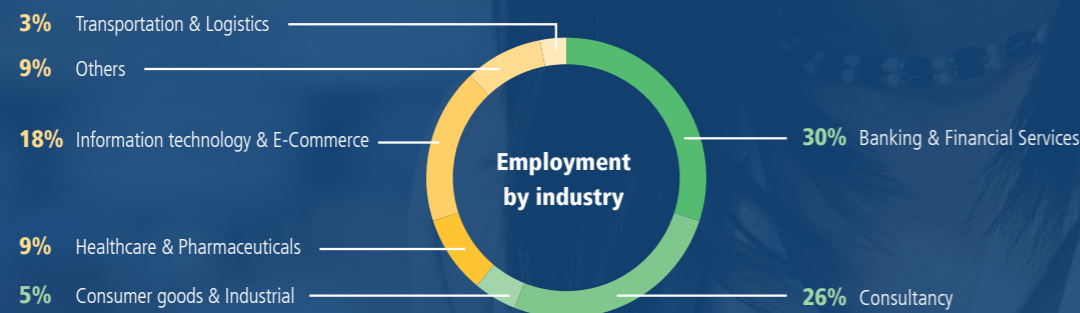

### AI Lab

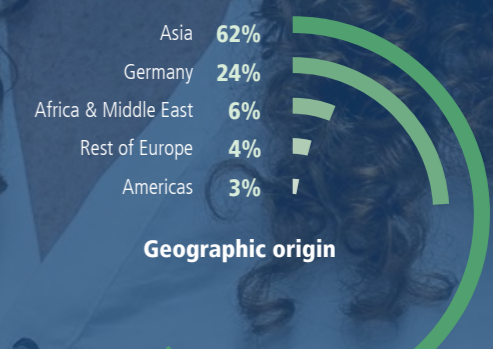
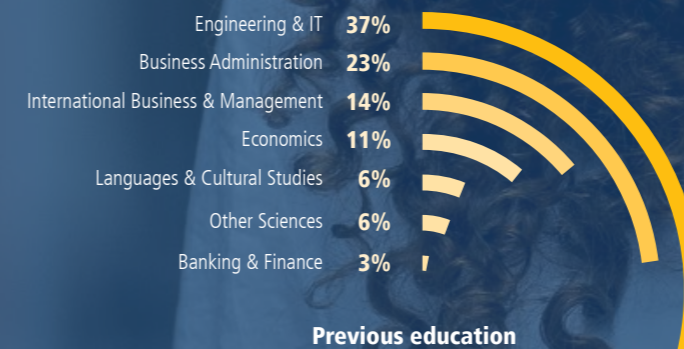

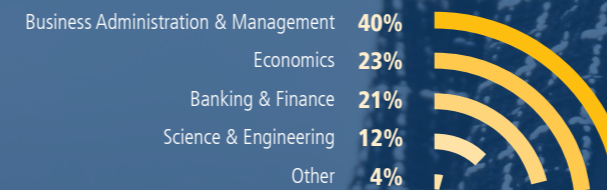
**Business / Immersion tracks**

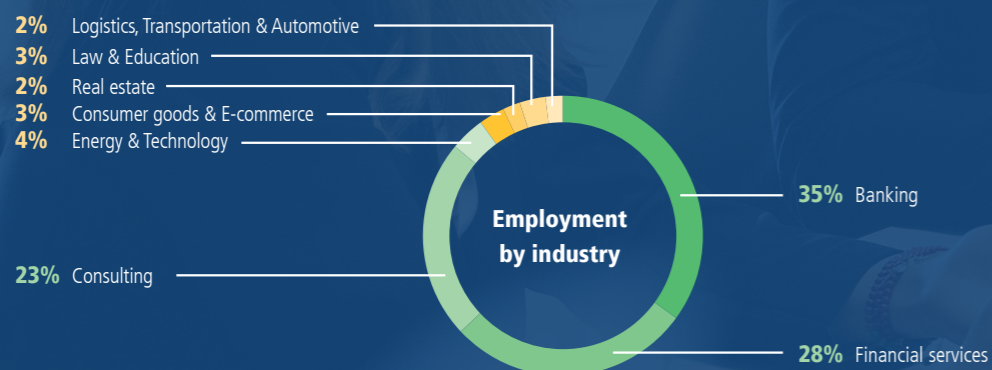

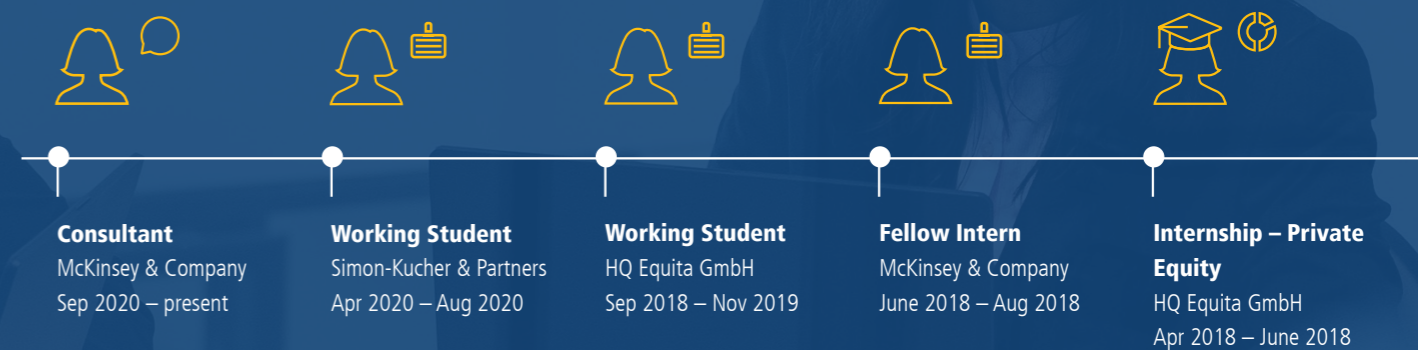
